Whereas, vide this Department's Order of even number dated 2<sup>nd</sup> May, 2020, directions have been issued regarding opening of offices, attendance and timings of Class-I to Class-IV employees and outsourced staff under the Government of Himachal Pradesh w.e.f. 4<sup>th</sup> May, 2020 till further orders.

Whereas, queries are being received from various quarters regarding opening/ functioning and presence of teaching and non-teaching staff of educational institutions.

Whereas, the Ministry of Home Affairs, Government of India vide Order number 40-3/2020-DM-I (A) dated 1<sup>st</sup> May, 2020 has extended the 'lockdown' period in all States for two weeks w.e.f. 4<sup>th</sup> May, 2020 and issued revised consolidated guidelines in this regard. Under Para 4 (vi) of these guidelines, all schools, colleges, educational/ training/ coaching institutions etc. shall continue to remain closed throughout the country and under Para 4 (ix) of the guidelines ibid, all social/ political/ sports/ entertainment/ academic/ cultural/ religious functions/ other gatherings have been prohibited during this period.

And Whereas. the Government of Himachal Pradesh, Department of Revenue (Disaster Management Cell) vide Order number Rev (DMC)(C) 20-2/2020-COVID-19 dated 2<sup>nd</sup> May, 2020 has directed to ensure strict compliance of the guidelines ibid during the extended period of the 'lockdown'.

**Now therefore,** in continuation of this Department's Order of even number dated 2<sup>nd</sup> May, 2020, it is clarified that this Order shall not be applicable to the officers/ officials working in the educational institutions, schools, colleges, universities, technical and vocational training institutes, ITI's, Polytechnics, Engineering Colleges etc. under the Government of Himachal Pradesh and such institutes/ institutions, in public and private sector, shall continue to remain closed w.e.f. 4<sup>th</sup> May, 2020 till further orders.
