Order

Whereas, in order to contain the spread of Novel Corona Virus (COVID-19) to a certain extent by taking preventive, precautionary and pre-emptive measures for social distancing, instructions have been issued to regulate and stagger the attendance, timings for arrival, lunch and departure as well working hours of the employees in various offices under the Government of Himachal Pradesh in the past few days from time to time.

Whereas, further directions were issued vide order dated 04.05.2020 to all the Controlling Officers to exempt the employees, who are persons with disability (DIVYANGJAN) and who require assistance of other person(s) to reach the workplace, from attending office(s), till opening of the public transport.

Whereas, in view of the Ministry of Home Affairs, Government of India decision to partially exist from the 'lockdown', the order was issued by the State Government on 31.05.2020 that all offices under the Government of Himachal Pradesh shall remain open on all working days with 100% attendance of all officers/officials, with certain conditions.

Whereas, on receipt of number of requests and in order to ensure properly the measures for social distancing, it is deemed appropriate to exempt the employees, who are persons with disability (DIVYANGJAN) and who require assistance of other person(s) to reach the workplace, from attending their office(s).

Now, therefore, in exercise of the powers vested in me under clause 3 of the Himachal Pradesh Epidemic disease (COVID-19) (Amendment) Regulations, 2020 notified on 14th March, 2020 under the Epidemic Diseases Act, 1897 and in partial modification of this department's Orders of even number dated 31st May, 2020, it is hereby ordered that the employees, who are persons with disability (DIVYANGJAN) and who require

assistance of other person(s) to reach the workplace, shall be exempted from attending office, in the public interest, till further orders.
