This is with reference to letter No.EDN-B-F(1)-10/2020-misc dated 20-06-2023 received from the Secretary (Education) to the Govt. of Himachal Pradesh vide which inspection report of Rajiv Gandhi Model Day Boarding schools, colleges and schools in Manali & Kullu constituency has been submitted to this Directorate (copy enclosed alongwith its enclosures).

3. Inspection of GC Kullu - on May 23<sup>rd</sup> GC Kullu was inspected. Staff welcomed SS Sh Pankaj Rai ji who discussed various issues that he can assist being ex student of college. Various issues that were discussed and resolved at spot are:-

(i) College staff informed him about shortage of land available in college for various future extension activities in the light of existing various PG/UG/ Self Finance courses running in college and moreover in view of massive student strength of 5600 in college. Worthy SS (Edu) Sh Pankaj Rai assured college administration help the getting 20 bighas of additional land in at old Angora Rabbit farm in Pirdi which is now under Forest department for which principal was asked to move complete proposal with Deputy Commissioner Kullu.

(Action to be taken by Principal Kullu with DC Kullu)

(i) Thereafter worthy SS (Edu) Sir enquired about status various development/ construction works going on in college. Two major construction works going on college were (a) Administrative block and (b) Indoor stadium. The work of Administrative block started since 2016 was told to be expedited for which he was informed that work will be completed in two months. For Indoor stadium there was need of more funds for which Principal was directed to move proposal for additional required funds to AD department through proper channel which WSSE sir will try to get from Finance department. Joint Director apprised worthy SS (Edu) that there were used to be funds in college also in AF, BF and CDF which can also be explored to be utilized.

(Action to be taken by Principal GC Kullu)

(ii) The WSSE sir raised the question of shabby condition of college gate which must be refurbished. College administration apprised SS sir that new college gate is being planned and drawing as well as estimate is being pursued. WSSE sir also provided college administration model gate design that can be made to glorify such an old and central college of district. He directed to make estimate of this gate at entrance of college according supplied design and construct the same from its own funds which College administration agreed to expedite the same.

(Action to be taken by Principal & CDC of College)

(iii) Accreditation with NAAC which expired since 2021 was also asked by worthy SS (Edu) to be done in time bound manner which Principal assured to be done in next six months.

(Action to be taken by Principal and IQAC of College)

(iv) Thereafter worthy SS (Edu) Sh Pankaj Rai with JDHE Dr. N.L. Sharma and staff took round of entire campus and WSSE was pained see the pathetic conditions of all the toilets in college and directed Principal and college development committee to act at once. He was apprised that there were four sweeper engaged from local funds. WSSE directed college administration to take work from them according to existing SOP taking work from sweeper for full hours for which they are engaged in morning and evening time as per their term and condition.

(Action to be taken immediately by Principal & CDC of College)

(v) He also directed to get audit of installed costly Automatic fire fighting system done from fire department and also refill or check existing chemical filled fire extinguishers system, whose next date of inspection expired way back in 2020,



also be refilled or get checked from fire department. He also directed college Eco Club of college to beautify the available green patch available in college. He directed to furnish Music (Instrumental) room with matting and mattresses like one done in Music (vocal) room. The condition of conference hall contained debris of bird residue and needed urgent repair which worthy SS (Edu) flabbergasted to see. The water supply in various coolers was not available and purifiers were not working on which sir asked:- Do student not protest for same in this college?

**(All these Action were to be taken on priority by Principal & College development committee & ATR reported to him through proper channel)**

4. **Inspection of GBSSS Dhalpur:** The school which started in 1926, one of the oldest in Kullu district and in which worthy SS (Edu) and many eminent personalities studied was inspected after GC Kullu on same date i.e May 23. Various issues discussed and resolved were:-

(i) The old building was inspected and its heritage status development or new building to be made being decided by committee headed by SDM Kullu was told to be expedited. Worthy SS (Edu) were of view that its heritage status be retained and building be refurbished as per other such education buildings in the state and he will provide all help it needs for the same.

**(Action by Principal & DDHE, DDEE to take up the matter lying with SDM)**

(ii) The condition of cleanliness due to leakage of water from one of building made along breast wall at back side boundary of school was asked to be taken up urgently with Ex-En PWD and WSSE will also ask Ex-En to visit the spot and make estimate to for exit of water coming underneath this building for otherwise it can lead to many diseases.

**( Action to be taken by Principal, DDHE, DDEE)**

(iii) Unserviceable Wooden material stocked in various rooms was asked to repair if possible otherwise written off by following all codal formalities.

**( Action to be taken by Principal)**

(iv) Worthy SS (Edu) discussed in detail about falling student enrollment in schools and asked entire teaching community present to think seriously act in mission mode to reverse the same.

**( Action to be taken by Principal, DDHE, DDEE)**

(v) " Khel Khle Men Swachhta" scheme which was started in L&S in various schools with active participation of Deputy Director was told to be taken up in Kullu district also for which DD inspection agreed to start the same in 50 selected schools of district.

**( Action to be taken by DDHE, DDEE)**

5. **Inspection of Primary School Khori Ropa:** There after worthy SS (Edu) Visited primary school at Khori Ropa where cleanliness and teaching were found to quite good. Worthy SS (edu) was asked to provide funds for Chowkidar Residence for which he asked Incharge Primary school to make complete proposal and send through proper cahnel to AD (Edu) for required funds. He also on the spot directed

staff to use special low height wooden benches ( Sholtas) to be used for mid day meal eating by students after thorough cleaning them.

6. Inspection of GC Haripur Manali: On the last leg of inspection GC Haripur ( Manali) was also inspected on May 23. The various issues discussed and sorted are :-

(i) Principal demanded change of existing Boy's hostel to Girls hostel as enrolment in Boy's hostel only 12 against sanctioned strength of 80. For which special secretary (Edu) asked Principal to send complete proposal through proper channel. **( Action to be taken by principal)**

(vi) The work of Principal residence was told to be expedited by worthy SS (Edu). Work of NACC whose accreditation expired in 2022 was also told to be done expeditiously so that more grants from centre can be lifted. Monthly repost of Biometric were told be generated and timely sent to higher authorities. The outdated fire extinguishers were told to refilled/ checked which expired in 2016. The toilets were told be regularly cleaned as per existing SOPs administration to take work from them according to existing SOP taking work from sweeper for full hours for which they are engaged in morning and evening time as per their term and condition. **( Actions for all these works to be done immediately by principal and ATR sent to WSSE through proper channel)**

(ii) The case on recovery of penal rent from teachers residing in Govt residence made in college whose case was filed in High court also was also discussed in detail. WSSE directed college principal to send point wise report of complete case of recovery of penal rent from teachers who were allotted residence to him. **( Action to be taken by Principal )**

Principal Manali had also requested WSSE to allocate funds to make over bridge between primary and secondary buildings for which JDHE was directed by WSSE to visit on 24<sup>th</sup> May, was inspected by JDHE and Principal Manali was told to make estimate and drawings and submit same through proper channel to higher education department. JDHE also visited SDM Manali office thereafter as directed by WSSE to discuss requirements for correct Tatima to be remade, for which SDM asked assisting Nodal officer Principal Manali to provide rectified Tatima at earliest for speedy diversion of forest land for RGMDBS at Jagatsukh.

In reference to your office letter No-EDN-HE(9)-7-1/2023-24-RGGM -Day Boarding School dated 13<sup>th</sup> July 2023 , kindly find herewith the Action Taken Report of Inspection done by worthy Special Secretary (Education) to the Govt. of HP and Joint Director Higher Education HP Shimla in respect of Govt. College Kullu is hereby submitted to your office for your kind information and further necessary action as per detail given below:-

**Para - 3 :- Inspection of G.C. Kullu:-**

Regarding the transfer of 20 Bighas land at Old Angora Rabbit Farm in Pirdi which is now under Forest Department, in this regard, the College administration wrote to the D.C. Kullu and thereafter met with the S.D.M. Kullu Sh. Vikas Shukla on dated 26.07.2023 and he told that there is no such land available at Old Angora Rabbit Farm in Pirdi (Kullu) which has already been occupied by others.


- (i) Construction work of Indoor Stadium is in progress and the proposal for additional requirement of funds of Rs. 3,17,72,000.00 only has been sent vide this office letter no-EDN-GCK-(E-6)-2020-21-1755 dated 28.07.2023 to the Director of Higher Education HP Shimla for further necessary action.
- (ii) Construction of College Gate:- As regards to erect College gate near NH main road was cancelled due to the land dispute with a private party under court case LMA No:- 104/20 titled as Neeraj v/s state of HP. It has been decided to erect the Model College Gate near Arts Block Phase-II. The work will be started soon as and when we get the estimate from HPPWD.

- (iii) Work for accreditation by NAAC is in progress and we are going to upload the IIQA soon as we have prepared SSR and the same will be done in next few months.
- (iv) The necessary instructions have been issued to all the sweepers and now they are working full hours and all the toilets of the college are neat and clean.
- (v) All the fire Fire Extinguishers have been refilled on dated 24.04.2023 and Audit of the Automatic Fire Fighting systems will be done from Fire Department very soon.

The beautification of green patches in College campus is in progress by the Eco- club of College.


The matting and mattresses of Music (instrumental) room will be done soon and the repair of the Conference Hall is in progress and will be completed soon.
