Subject: **Reservation for Economically Weaker Sections (EWSS) and Persons with disability (PWDs) in Educational institutions for admission in various courses.**

Sir,

I am directed to say that pursuant to coming into force "The Constitution (One Hundred and Third Amendment) Act, 2019" with effect from 14<sup>th</sup> January, 2019 subsequently issuing of guidelines in this regard by the Ministry of Social Justice and Empowerment Government of India and Ministry of Social Justice and Empowerment Government of India and Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, Government of India, the matter regarding implementation of Constitution (one Hundred and Third Amendment) Act, 2019 and in compliance of orders passed by the Hon'ble High Court in **CWPIL No.103 of 2017 titled as Court on its own Motion versus State of H.P.** and others dated 05-09-2017 to implement the section 32 of the Persons with Disabilities Act, 2016, circulated by the Government of India vide their later dated 19-04-2017 under which the percentage of

reservation of seats for the purpose of seeking admission for disabled students has been extended from 3% to 5% were under active consideration at Govt. level. It has been decided with the prior approval of competent authority that as a result of this decision of the State Government, it is hereby notified that 10% reservation would be provided for Economically Weaker Sections and 5% reservation would be provided for Persons With Disabilities (PWDs) in Educational Institutions for the purpose of admission in various courses on or after issuance of these instructions. The benefit of reservation under Economic Weaker Section (EWS) and Person with Disability (PWDs) can be given as per the reservation roster given at **Annexure-A** and **Annexure-B**.
