(Bachelor of Vocation),a three year degree programme, in 18 Government Degree Colleges of Himachal Pradesh through skill development in two Sectors viz. 'Retail Management' and 'Hospitality& Tourism'.

The First Party invited proposals from Training Service Providers to Impart Skill Development Training of 03 (Three) Year Bachelor of Vocation (B.Voc.) Programme in Sectors Viz. 'Retail Management' and 'Hospitality & Tourism' in existing 12 Government Degree Colleges of Himachal Pradesh from Academic Session 2017-18 to improve employability of youth in the State. The programme have been implemented based on the University Grant Commission (UGC) guidelines – Guidelines for Introduction of Bachelor of Vocation (B.Voc.) Programme in Universities and Colleges under the National Skills Qualification Framework (NSQF) issued in 2015 duly adapted to suit the requirements of Department of Higher Education, Government of Himachal Pradesh.

The Second Party submitted the RFP to impart such skill training through submission of a technical proposal against the Request for Proposal mentioned above;

The programme have been implemented based on the University Grant Commission (UGC) guidelines – Guidelines for Introduction of Bachelor of Vocation (B.Voc.) Programme in Universities and Colleges under the National Skills Qualification Framework (NSQF) issued in 2015 duly adapted to suit the requirements of Department of Higher Education, Government of Himachal Pradesh.




